11 WMA PRESIDENT : STAN PERKINS

The WMA President briefly outlined recent developments and proposed future activities. Daegu 2017 was very successful and over 8000 entries are expected for Malaga, Spain in September this year. The WMA Indoor Championships are in Torun, Poland in 2019 and Toronto, Canada will be host city for the WMA 2020 Stadia Championships.

12 CONSTITUTIONAL AMENDMENTS

Motions from OMA Council to amend the OMA Constitution.

26.5 Nomination for OMA Council

Clause 26.5 be amended FROM "Any Affiliate shall have the right to nominate any candidate from its own or other Affiliate " TO " Nominations in accordance with section 26.3 can only be made by the Affiliate of which the candidate is a member"

Carried 9 votes for 2 votes against 2 abstained. The provisions of clause 37.1 regarding the vote requirement for a change therefore obtained.

32.2 The Conduct of Meetings

Clause 32.2 be amended FROM "A quorum for an Assembly General Meeting shall constitute twelve persons, five of whom must be elected members of Council" TO

"A quorum for an Assembly General Meeting shall constitute twelve persons with voting rights, comprising at least five elected members of Council" **Carried** all 13 votes For.

13 2019 OMA Championships - Report by ANQ

HMcD made a presentation in relation to Mackay QLD which has been accepted by the OMA Council as the host city. The Championships will be held 31 August to 7 September 2019 The Athletics facility has not yet been built but completion is planned for early 2019.

14 2021 OMA Championships

LS announced to the meeting that the OMA Council had selected Norfolk Island as the host nation. BJ then made a presentation to the meeting highlighting the attractions and facilities of the Island. The provisional date is 17-23 January 2021.

15 Proposed Motions to WMA General Assembly, Malaga Spain 2018

Motion1: That one (1) year age grading be reinstated to assist the holding of events which require such percentages to have accurate performance results. *Motion2:* That a sub-committee of up to seven (7) persons be appointed by WMA to undertake the revision of the Age Graded Tables ready for publishing in 2020. *Motion 3* That WMA arrange for the Age Graded Tables be reviewed five years.
